By signing below, I/we agree to the terms and conditions accompanying this form. I/We agree to pay \$20.00 for each Domestic Wire transfer and \$50.00 for each International Wire transfer requested and understand that this charge will be assessed at the time the wire transfer is processed by the Bank. The Bank is hereby authorized to rely on this authorization and agreement until a new authorization and agreement, certified by an authorized signer, is received by the Bank, even in the event that any or all of the foregoing information may be changed or cancelled.

This agreement will expire one year from the date of signature, unless previously revoked or otherwise indicated.

Wire Transfer Terms

1. Customer ("you") authorize Citizens Savings Bank ("us"/"we") to make the multiple wire transfers described on this form (if applicable).
2. By signing this agreement for multiple wire transfers you authorize us to rely on email, voice, online, or faxed instructions to send future wire transfers to the beneficiary indicated on this form.
3. We will not act upon any wire transfer instructions if: we are unable to obtain proper and satisfactory verification of the instructions; there is inconsistency between such instructions and information perviously supplied to us by you; the instructions are not submitted in accordance with our established security procedures; or we suspect the instructions are not genuine.
4. You agree to hold us harmless from any loss which occurs if your instructions are incomplete, ambiguous, or incorrect. We are not required to seek clarification from anyone regarding ambiguous instructions. If we cannot complete a wire transfer (e.g., because of ambiguity), we will notify you orally or in writing by the end of the next business day.
5. If you identify the Beneficiary, the Beneficiary Bank, or an Intermediary Bank by name and number, payment of the order may be made based on the number alone, even if it identifies a person or bank different from that shown on the front of this form.
6. We may transfer funds through an Intermediary Bank or wire transfer system which is different from that shown in your instructions.
7. If we receive your payment order after our processing cutoff time of 2:00 p.m. or on a Saturday, Sunday, or federal holiday, we may process it on the next wire transfer business day. A delay may also occur if an Intermediary Bank or the Beneficiary's Bank is not accepting a payment order (e.g., due to local holiday).
8. You do not have a right to cancel or amend a wire transfer once the wire transfer has been transmitted by us. You agree to hold us harmless from all claims and damages if we attempt (successfully or otherwise) to comply with your request. If your order involves foreign exchange, and we attempt to comply with your cancellation or amendment request, or if we do not send the wire transfer because insufficient funds are in your account, our damages may include losses due to exchange rate fluctuations and other costs of canceling, amending, or covering the order from any counter party to the order.
9. Your wire transfer will be debited from the Citizens Savings Bank account number indicated on this Agreement, and it will be reflected on your next periodic statement. You will not receive any other notice from us regarding your wire transfer. You agree to notify us immediately if you notice any discrepancy between your statement and your payment order or you discover a problem with your wire transfer. You must send us a written notice of the problem, including a statement of the relevant facts, within a reasonable time (not to exceed 14 days from the date you first discover the problem or receive a statement or notice reflecting the erroneous wire transfer, whichever occurs first). Upon requesting a payment order we reserve the right, prior to debiting your account for the requested wire transfer, to place a hold on your account for the amount of funds requested to be transferred.
10. Foreign wire transfers may be subject to delays, charges imposed by other banks, and charges in foreign currency exchange rates.
11. We will not be liable for consequential, special, or exemplary damages or losses of any kind. We will not be liable for any failure to act or delay due to: a lack of sufficient available funds in your account; circumstances beyond our reasonable control; fire, flood, or natural disasters; communication failures; labor disputes; any inaccuracy or ambiguity in your instructions; the action or inaction of others; or any applicable government or wire transfer system rule, policy, or regulation.
12. You agree that we will have sufficient time to set-up and verify your multiple wire transfer request (at minimum 3 business days) regardless of the "date" indicated on this Agreement (if applicable).
13. You agree that we may amend, add to, or delete from the Terms of this Agreement, or terminate this Agreement at any time if we provide you with notice personally, by mail, or by reference on wire transfer agreement forms. Any amendment or termination will only affect your or our rights and obligations for wire transfers that occur after the new terms by continuing to request wire transfers.
14. You agree that you will notify us in writing, by completing a new Wire Transfer Agreement, if the instructions and/or authorization provided on this Agreement are changed or cancelled. In addition, you agree that we will have reasonable time (at minimum, 3 business days) to act upon your change/cancellation request.
